Earaheedy-Imbin FLEM Surveys Commence




Figure 1 Location plan showing Lodestar's Earaaheedy-Imbin Project in relation to Rumble Resource's Chinook Zn-Pb discovery.

Lodestar Minerals Limited (“**Lodestar**” or “**the Company**”) (ASX:LSR) provides the following update on exploration activity on the Company’s Earraheedy-Imbin project. The Earraheedy-Imbin project is located on the northern margin of the Earraheedy Basin and 70km northeast of Rumble Resource’s Chinook Zn-Pb discovery (see Figure 1).

HIGHLIGHTS

- In preparation for planned RC drilling, Lodestar has commenced fixed loop electromagnetic (FLEM) surveys over three base metal targets along strike from or in proximity of the Main Gossan copper occurrence.
- The three targets, SC3, MC8 and MC9 are associated with historic base metal and pathfinder element anomalies¹.
- The FLEM surveys follow the completion of the soil geochemistry program designed to prioritise drill targets from the multiple conductors identified by the Xcite EM survey².

The fixed loop EM surveys are expected to be completed within two weeks and will define the first targets for drill testing within Lodestar’s 950 sq km Earraheedy-Imbin project.

Samples from the UFF™ soil program will be submitted for analysis and will assist in determining the drilling priority for the numerous other EM conductors identified by the Xcite EM survey.

Lodestar Managing Director, Bill Clayton commented “*Completion of soil sampling over the Imbin Cu-Au corridor marks a significant first step in evaluating the base metal potential of the project, follow up fixed loop EM surveys followed by drill targeting are planned to make for a busy schedule through the second half of 2022*”.

About Lodestar

Lodestar Minerals is an active Western Australian gold and base metal explorer.

Lodestar's projects comprise the advanced Nepean Nickel Project JV, the Ned's Creek JV and the 100% owned Camel Hills, Earaaheedy-Imbin, Jubilee Well, Bulong and Coolgardie West projects.

The Earaaheedy-Imbin Project is a major strategic land holding in the emerging Earaaheedy Province, site of Rumble Resource's recent and potentially world-class Zinc-Lead discoveries. The Imbin Project is located on the northern margin of the prospective basin and is the site of significant historic copper intersections in drilling and approximately 20km of strike of the target Yelma-Frere unconformity.

Lodestar discovered multiple zones of syenite intrusion-related gold mineralisation at the Ned's Creek Project on the Yilgarn craton margin, 150km west of Imbin. Vango Mining Limited is earning a 51% interest in the Ned's Creek JV by contributing \$5M of expenditure over 3 years.

Bulong and Jubilee Well are recent acquisitions in highly endowed gold districts; first-pass drill programs have been planned. Coolgardie West, located 12km west of Coolgardie, has potential for

greenstone hosted gold, nickel and LCT pegmatite mineralisation with priority lithium and gold drill targets identified by soil geochemistry.
