PEAK HILL-DOOLGUNNA PROJECT - TENEMENT ACQUISITION

Lodestar Minerals (Lodestar) is pleased to advise that it has acquired an additional two exploration licences to complement its 2000 square kilometre land holding in the Peak Hill-Doolgunna district. The acquisition confirms Lodestar's interest in developing additional opportunities in this under-explored province.

The consideration for the acquisition comprised \$ 25,000 in cash plus the issue of 250,000 fully paid ordinary shares at a deemed price of 13 cents each. Details of the tenements are listed below:




Figure 1 Location plan and simplified geology-Peak Hill-Doolgunna Project




Figure 2 Location of newly acquired tenements, (aeromagnetic data © Geoscience Australia, 2009)

The tenements are contiguous with the Marymia tenement block (Figure 1), lie between E52/2492 and E69/2662 and include the extensions of north east trending structures (thrust faults?) visible in the aeromagnetic data (Figure 2). There has been little previous exploration for gold or base metals within the new tenements, which have indications of major structures and possibly Archaean greenstone or Proterozoic sequences, concealed beneath an extensive but generally shallow layer of sand cover.

Lodestar is preparing a work program for the coming field season that is likely to include the acquisition of detailed aeromagnetic data, an extension of airborne VTEM electromagnetic surveys and auger/RAB geochemical sampling. Yours Sincerely,
